# STATISTICS REPORT FOR 2018 GROUPS OFFERED & PARTICIPANTS ANDERSON COUNTY RECOVERY

Dear Pastor and Community Leader(s),

Anderson Co. Recovery Living Free Community (ACR) was formed in February 2012 in a response to the communities need for help with addiction. ACR is a tax exempt organization under 501(c)(3) of the Internal Revenue Code, and is recognized by the IRS as such.

A Living Free Community ministry utilizes the small group curriculum-based ministry model, introduces biblical solutions and starts its participants on a Life Plan with solid bible-based foundations that doesn't conclude at the end of a small group. Rather, it helps point the way to a life of Christian discipleship and works to transition participants from the care of the Living Free Community ministry to the care of a local participating church.

The primary mission of a **Living Free Community** ministry takes on four distinct focus points, yet not restricted to these four. They are as follows:

**1. Referral.** Helping those in the latter stages of an addiction to find an appropriate residential treatment or recovery facility for the help they desperately need.

**2. Relationships.** Helping those, who are somewhat functional, and in earlier stages of their addiction, find help and hope through the small groups, and their personal Life-Plan of Recovery. This may involve ministry at county detention centers, and working with family and drug court participants.

**3. Realignment.** Helping families of addicts that may be struggling with enabling & codependency, establishing healthy family boundaries, as well as restoring healthy family relationships.

**4. Re-establishment.** Helping program graduates and ex-offenders have the support and accountability they need to be successful and drug free for a lifetime, and continue to grow in their faith that may have taken root during incarceration or program participation

# Life-Plan of Recovery

The Life-Plan of Recovery is based on 5 scriptural components of recovery. These are decision, positive peer choice, accountability, boundaries, & consistency.



This particular letter is to detail the number of participants and groups offered by the grace of God to the people of Anderson Co. in 2018.

In the last year, God has given Anderson Co. Recovery the opportunity to share the message of the life giving hope of Jesus Christ to hundreds of people. Below is a breakdown of the number of people and groups we were able to offer in 2018. Some participants have enrolled in multiple groups and are counted for each group they attend. The same resources (books, copies, folders, pens, highlighters, etc) are used with each group whether the participant is new or returning. By our estimates there are about 113 participants that have enrolled in more than one group.
